### System and Organization Controls (SOC1/SOC2) Audits

### Sarbanes-Oxley Compliance

We test the design and operational effectiveness of SOX company controls, including Business Process controls and Information Technology General Controls (ITGCs). This service evaluates identified deficiencies and provides recommendations for improvement. We also document key business processes through narratives, flowcharts, and risk matrices, conducting walkthroughs to assess the design effectiveness of controls based on PCAOB standards and the COSO framework.
